

How thick should the guardrail of the distribution box be

Top rails and midrails are at least 0.6 cm in diameter or in thickness. The top edge height of top rails, or equivalent guardrail system members, are 42 inches (107 cm), plus or minus 3 inches (8 cm), above the walking-working surface. The top edge height may exceed 45 inches (114 cm), provided the guardrail system meets all other criteria of paragraph (b) of this. How can we help you?
